

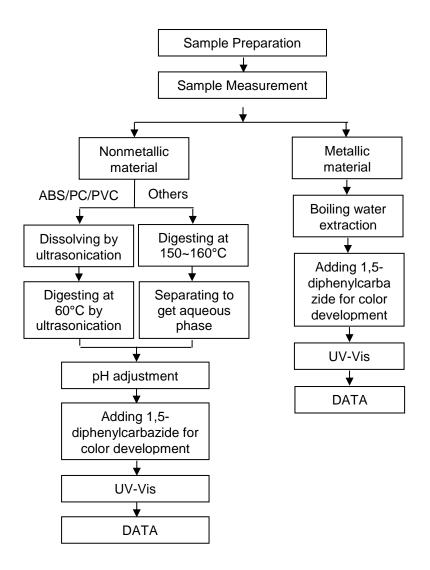



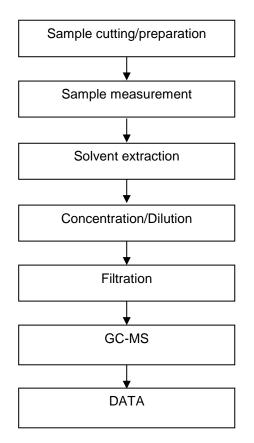

### **Phthalates Testing Flow Chart**







### **Halogen Testing Flow Chart**


